

Clinical Mental Health Counseling

Pre-licensure program disclosure

The clinical mental health counseling Master of Arts program at Indiana Wesleyan University seeks to prepare the program graduate for licensure and service in the clinical mental health counseling profession. Licensure procedures vary by state. The procedure in the state of Indiana is to register to take the National Counselor Examination, pass the examination, complete the application for licensure as a mental health counselor associate, and be approved by the Behavioral Health and Human Services Licensing Board.

Following successful program completion, the program graduate will have obtained requisite graduate coursework to apply for a mental health counselor associate license upon earning a passing score on the National Counselor Examination. Applicants also need to clear a criminal history check.
